It is our policy to try to treat medical emergencies on the farm, if possible. If not possible, we will try to contact you at the above telephone numbers. If we are unable to treat the problem and cannot get in touch with you, then we usually call our veterinarian to come to the farm and upon their recommendation, might send the horse to a clinic. We, or the doctors at the clinic, would then contact you with an update. If we still cannot get in touch with you, we will follow the course of treatment recommended by the clinic on your behalf. You authorize us to employ veterinarians and administer treatment at your expense. **Let us know if this is not the procedure you want us to follow.** You agree we are not responsible for any horse's injury or illness unless it is due to our gross negligence.

**II. Jurisdiction/Venue/Governing Law** - I hereby consent and agree that the legal venue for any dispute involving payment of services provided by Rockridge Stud, LLC shall be City Court for the City of Hudson, New York, where the amount in dispute is \$15,000 or less, and the Columbia County Supreme Court and/or County Court, Hudson, New York, where the amount in dispute is in excess of \$15,000. I further consent and agree that New York law shall govern any dispute involving services provided by Rockridge Stud, LLC and/or the payment of services related to same.

### **III. Billing**

You agree to pay all charges billed monthly (board, farrier, vet, etc.) within 30 days, after which a 1.5% interest charge per month shall be added. If collection is necessary, you will pay all legal fees and court costs. You understand that payment in full must be received **prior** to the time the horse leaves the farm. If you are more than 30 days past due you authorize us, at our option, to return the horses to the farm they came from and charge you for the shipping. Alternatively you authorize us, at our option, to sell the horses on your behalf and apply the proceeds to your bill. You remain liable for any deficiency. The daily board charge is: Mares \$40 (foals by side of mare \$9), Weanlings \$34, and Yearlings \$36. Foaling fee is \$550.
